Cooper Hurley Injury Lawyers donates over 1400 meals to local Foodbank!

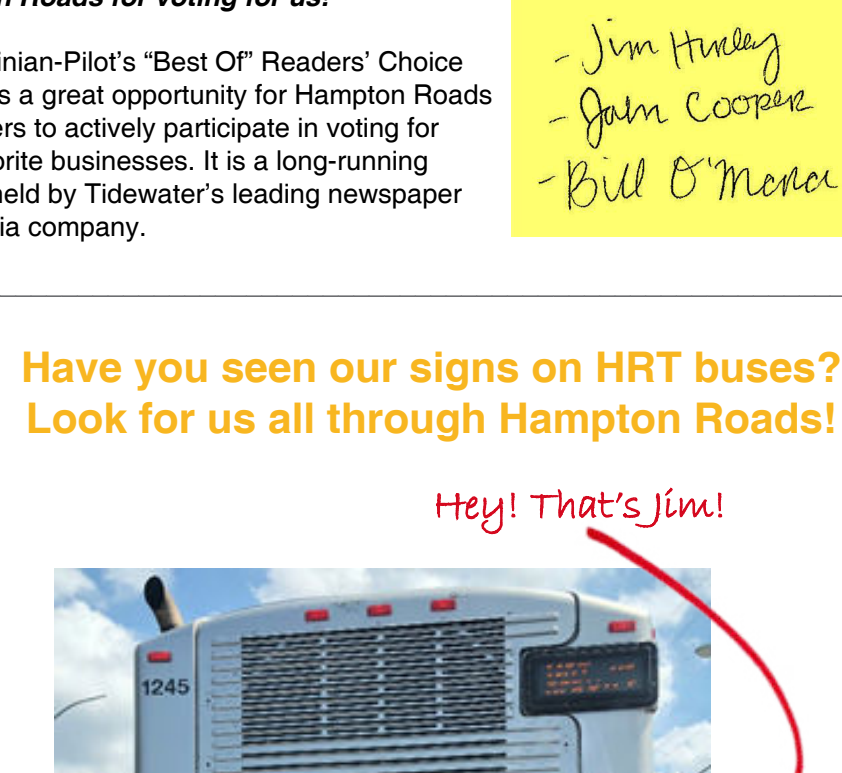

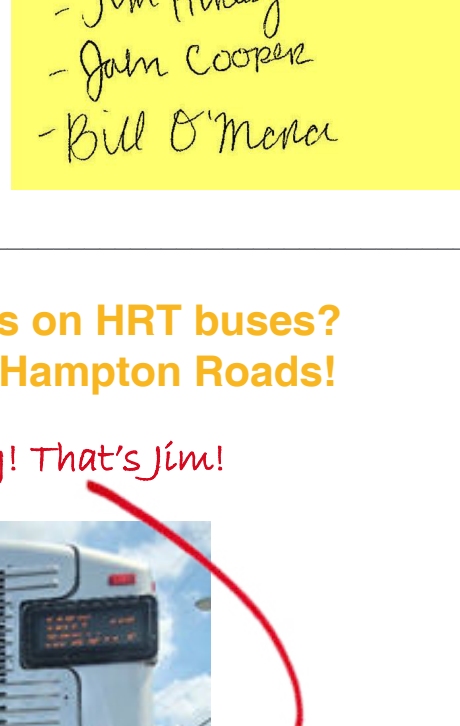

Cooper Hurley Injury Lawyers has been voted the best law firm in Norfolk in the 2018 Virginian-Pilot Readers' Choice awards!

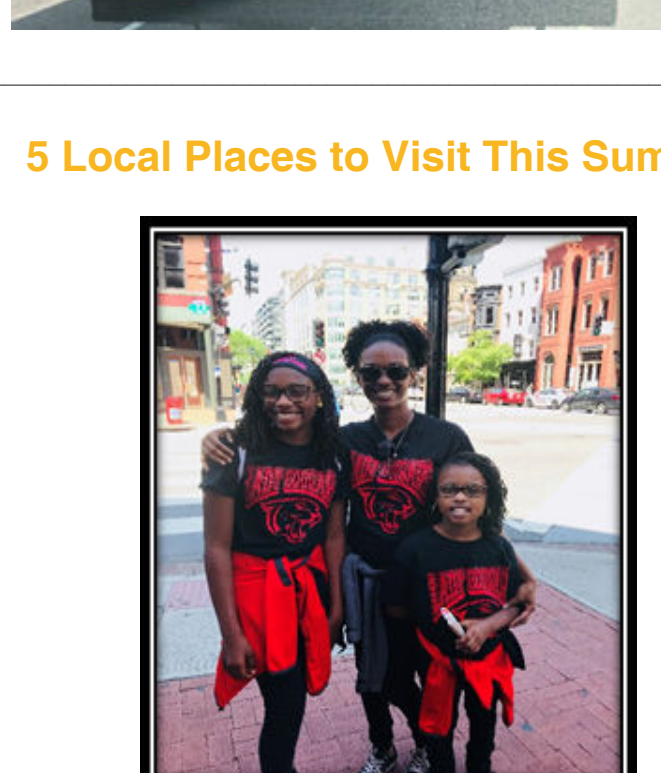

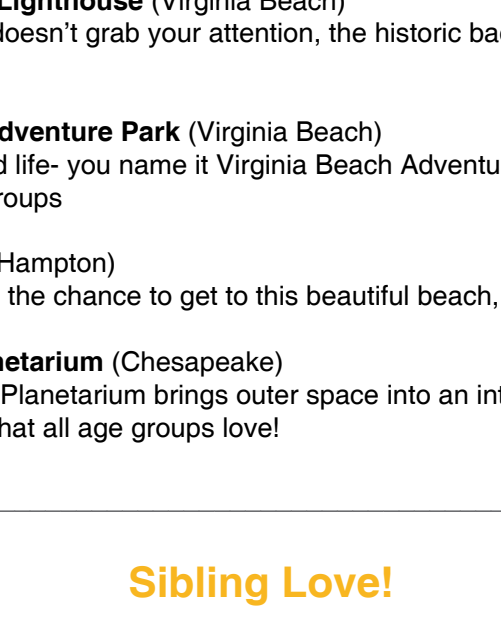

5 Local Places to Visit This Summer

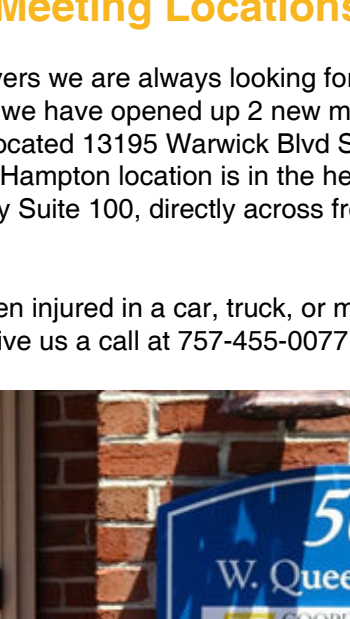


Hampton Roads has so many family friendly places to go to this summer. Here are a few of our favorites to catch some, sun, learn something new, and just enjoy the area!

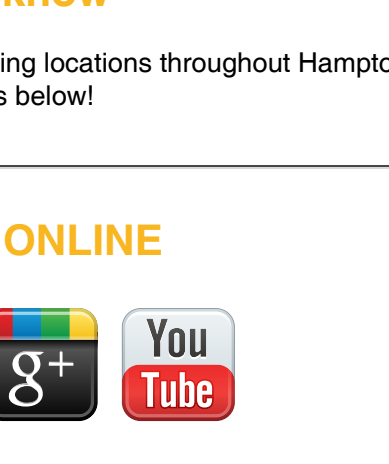
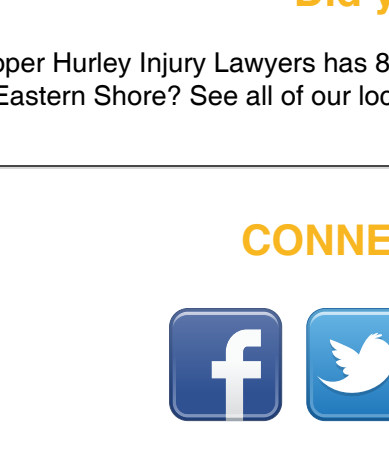
Worst Dad Jokes EVER!

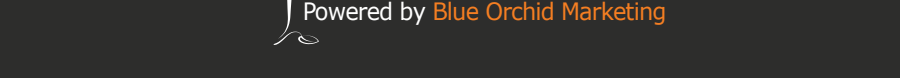
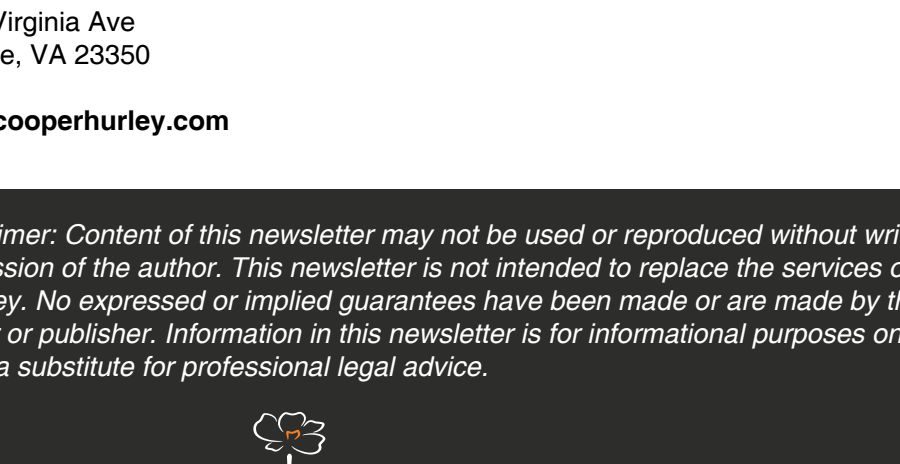
